

The signer is duly authorized by the Company to execute this agreement and by signature and date does obligate the Company to accept all terms, conditions and obligations herein.

The Buyer/Company is aware that some countries regulate the use of satphones or may charge license fees for same. The Buyer/Company assumes all responsibility for learning about and adherence to such regulations and licensing requirements and indemnifies IMS from any responsibility in this regard.

All sales are final. Products returned or refused after shipment or delivery are subject to 20% restocking fee, at IMS' discretion. Service contracts for airtime may have early cancellation fees. Payments are due per terms stated in offer/quotation, but in no case later than 30 days from date of invoice. Amounts due beyond 30 days incur 1.5% per month late fee.

The Buyer/Company specifically assumes all responsibility for:

- 1. proper use of satphone equipment including licensing requirements in the country of use.
- 2. all risk of confisgation, forfeiture, loss or damage to the equipment.
- 3. payment of full purchase and airtime price in the sales agreement or invoice.
- 4. payment of all airtime service charges incurred on phone, regardless of actual user, even in event of lost phone.

IMS responsibility:

- 1. IMS reserves title to and a purchase money security interest in any products and all system components delivered until entire invoice is paid in full.
- 2. IMS bears no responsibility for installation, training or consulting unless specifically so stated in the sales contract.
- 3. IMS makes no warranty or representation to the Company with respect to the products or their performance or suitability for any particular purpose.
- 4. IMS is specifically not responsible for availability or lack of satellite connectivity or service anywhere in the world. IMS is not the service provider. Provision of service between any service provider and the Customer are subject to the terms and conditions specific to that service provider and awareness of and adherence thereto is the sole responsibility of the Buyer/Customer.
- 5. IMS shall not be liable for any loss, damage, personal injury, including death, or business loss of revenue, profits or goodwill resulting directly or indirectly from the use, misuse, operation, performance or non-performance of the products or services sold hereunder.
