3. IMS bears no responsibility for installation, training or consulting unless specifically so stated in the sales contract.
4. IMS is specifically not responsible for availability or lack of satellite connectivity or service anywhere in the world.
5. IMS shall not be liable for any loss, damage or personal injury or death resulting from the use, misuse, operation, performance or non-performance of the products or services sold hereunder.

SPOT Messenger How to setup your profile and share pages (once activated).

With Share pages, you allow others to follow your SPOT beacons, without seeing your account.

Upon setup, the OK, HELP, Tracking, and SOS (previously called 911) Buttons will go live.

Don't even think about pressing SOS unless you're in big trouble.

If SOS is pressed by mistake – repress for 3 seconds to cancel.

>> See PROFILE for each unit. Click: Profile > Default > Change Profile...

Edit setups for **OK** and **Help** button. Create preset messages. Add/remove contacts -
- enter contact emails or cell phone numbers as you like.

>> SOS section – VERY IMPORTANT - Add what you think best for serious emergency contact info.

In a real emergency – the more info, the better. Got a special trip coming up – describe anything helpful to rescuers, in case. Set up one or more profiles for a given Spot unit..

That's it. **Just remember - SAVE, SAVE, SAVE.**

My GPS Locations - shows history of beacons from your SPOT(s). You can filter, or control what shows.

This is where you will see any message beacons (for OK, Help, or Tracking) from the SPOT unit.

If no messages yet – page will show just a big map of US.

'Set-filter' can be set to keep messages here for 7 or 30 days, then they disappear.

Note that any beacons here will also be seen on your share page (where they disappear in 7 days).

For any messages (beacons) you can select and **“view on Map”**. Or export to Google Earth (export “KLM”)

The 'Earth' program must be installed on your Cp. It's a free program and pretty cool.

Share - Let SPOT create your Share page URL address. Manage your existing Share pages.

- (a) Create: Name a share page [e.g., Spots up North] for selected Spots you want on this 'report page map'. (more than 10 active units can slow page download. Group your units, make several pages as needed)
Set as public or private - via password. Read over other selections.
Choose “Send it to yourself”. Let SPOT generate the page link. Then you'll have the link.
Send link to (share with) whomever you wish. Save as Bookmark.
- (b) Manage pages: See Name & ESN for each Spot Unit in this account. See settings and actions.
Here you can manage several share pages - activate, sleep, delete, etc.
Send link to (share with) whomever you wish. Tell them to Save as Bookmark.
